ORDER

On December 27, 2013, PowerSource Philippines, Incorporated (PSPI) filed an application for authorization to provide electricity service in Malapascua Island, Brgy. Logon, Daanbantayan, Cebu as a qualified third party (QTP) and for issuance of the corresponding authority to operate (ATO) and for approval of the QTP Service and Subsidy Agreement (QSSA) with National Power Corporation (NPC), with prayer for issuance of provisional authority.

Relative thereto, on March 10, 2014, the Commission issued an Order provisionally approving the instant application.

The said provisional authority is set to expire on March 9, 2015.

Considering that the Commission is still in the process of evaluating the instant application, the provisional authority granted in the Order dated March 10, 2014 is hereby **EXTENDED** until revoked or made permanent by the Commission.
