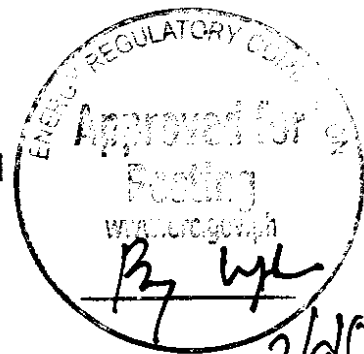

D E C I S I O N

The Commission takes note of the "Formal Offer to Settle Fines and Penalties" filed by Camiguin Electric Cooperative, Inc. (CAMELCO) on March 3, 2009, offering to pay as settlement of the case fifty percent (50%) of the total amount of the imposable penalty for the alleged violation, computed as follows:

For Failure to Implement the Energy Regulatory Board's Order on PPA	
Under C.A. 146 up to June 17, 2002 (PhP200 a day for everyday of violation)	
(October 3, 2001 to June 17, 2002 (PhP200 x 258 days)	51,600
Under R.A. 9136 Initial Amount	100,000
Plus PhP100 a day for every day of violation (June 18, 2002 to December 6, 2005) (PhP100 x 1,267 days)	126,700
TOTAL	278,300
Fifty Percent (50%) thereof	139,150

Finding the said offer to be just and reasonable, and in accordance with the "Guidelines to Govern the Imposition of Administrative Sanctions in the Form of Fines and Penalties Pursuant to Section 46 of Republic Act No. 9136", the same is hereby **ACCEPTED and APPROVED**. Accordingly, Camiguin Electric Cooperative, Inc. (CAMELCO) is hereby directed to remit the total amount of **ONE HUNDRED THIRTY NINE THOUSAND ONE HUNDRED FIFTY PESOS (PhP139,150.00)** in the name of the Energy Regulatory Commission within fifteen (15) days from receipt hereof.
