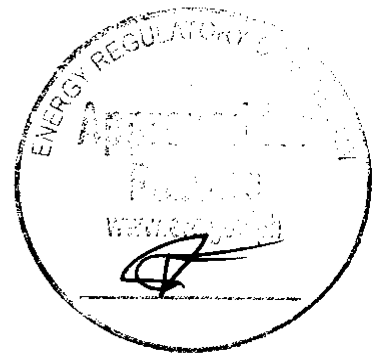

DECISION

The Commission takes note of the “Manifestation with Offer to Compromise” submitted by Zamboanga City Electric Cooperative, Inc. (ZAMCELCO) on February 8, 2010, offering to pay as settlement of the case fifty percent (50%) of the total amount of the imposable penalty for the alleged violation, computed as follows:



Finding the said offer to be just and reasonable, and in accordance with the "Guidelines to Govern the Imposition of Administrative Sanctions in the Form of Fines and Penalties Pursuant to Section 46 of Republic Act No. 9136", the same is hereby **ACCEPTED** and **APPROVED**. Accordingly, Zamboanga City Electric Cooperative, Inc. (ZAMCELCO), is hereby directed to remit the total amount of **ONE HUNDRED TWENTY NINE THOUSAND NINE HUNDRED PESOS (PhP129,900.00)** in the name of the Energy Regulatory Commission within fifteen (15) days from receipt hereof.
