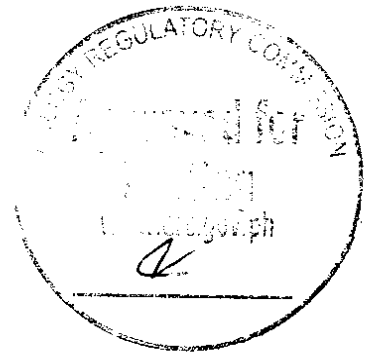



The Commission takes note of the "Motion to Approve Offer of Compromise" filed by Iligan Light and Power, Inc. (ILPI) on August 12, 2010, offering to pay as settlement of the case, fifty percent (50%) of the total amount of the imposable penalty for the alleged violation, computed as follows:



Accordingly, Iligan Light and Power, Inc. (ILPI) is hereby directed to remit the total amount of **NINE HUNDRED FIFTY SEVEN THOUSAND TWO HUNDRED FIFTY PESOS (PhP957,250.00)** in the name of the Energy Regulatory Commission within fifteen days (15) from receipt hereof.
