D E C I S I O N

The Commission takes note of the "Motion to Approve Offer of Compromise" filed by Iligan Light and Power, Inc. (ILPI) on April 23, 2010, offering to pay as settlement of the case fifty percent (50%) of the total amount of the imposable penalty for the alleged violation, computed as follows:

Fifty Percent (50%) thereof	230,000.00


Finding the said offer to be just and reasonable, and in accordance with the "Guidelines to Govern the Imposition of Administrative Sanctions in the Form of Fines and Penalties Pursuant to Section 46 of Republic Act No. 9136", the same is hereby **ACCEPTED** and **APPROVED**. Accordingly, Iligan Light and Power, Inc. (ILPI) is hereby directed to remit the total amount of **TWO HUNDRED THIRTY THOUSAND PESOS (PhP230,000.00)** in the name of the Energy Regulatory Commission within fifteen days (15) from receipt hereof.
