DECISION

On January 19, 2010, the Commission issued a Show Cause Order directing Ifugao Electric Cooperative, Inc. (IFELCO) to submit an explanation under oath why no administrative penalty should be imposed upon it, and/or criminal action instituted against its directors and officers in view of its failure to implement the refund Order on its Purchased Power Adjustment (PPA).

On March 9, 2010, IFELCO filed a "Manifestation with Motion to Set the Case for Conference" which was granted by the Commission in an Order dated March 11, 2010 setting the conference on April 13, 2010. During the conference, IFELCO manifested that it started to implement the PPA refund in its March 2010 billing. On May 6, 2010, IFELCO submitted its "Compliance" attaching therewith various samples of its March 2010 billings as evidence of its compliance. Available records with the Commission confirm this.


Finding this as substantial compliance with the Commission's directive, albeit done belatedly, in the interest of justice, the Commission deems it proper, at this time, to simply issue a reprimand to IFELCO for its failure to comply with the Commission's directive on time.

WHEREFORE, the foregoing premises considered, respondent Ifugao Electric Cooperative, Inc. (IFELCO) is hereby **REPRIMANDED** for the delay in its implementation of PPA refund and **WARNED** that a similar offense in the future shall be dealt with more severely.
