

**ORDER**

On November 22, 2010, the Ifugao Electric Cooperative, Inc. (IFELCO) and the Provincial Government of Ifugao (PGI) filed an application for the approval of their power supply agreement, with prayer for the issuance of a provisional authority.

On January 31, 2011, the Commission issued an Order provisionally approving the above-captioned case, the dispositive portion of which is as follows:

**"WHEREFORE**, the foregoing premises considered, the Commission hereby **PROVISIONALLY APPROVES** the power supply agreement entered into by and between the Ifugao Electric Cooperative, Inc. (IFELCO) and Provincial Government of Ifugao (PGI) at a **modified rate of PhP2.5800/kWh** subject to the following conditions:

- a. The final generation cost that can be recovered shall be determined by the Commission in its Decision in the instant application; and
- b. In the event that the rates provisionally approved are found to be higher than the final rates, the amount corresponding to the excess shall be refunded by IFELCO to its customers by crediting the same in their electric bills over a period to be determined by the Commission.

**SO ORDERED.**

The said provisional authority is set to expire on January 30, 2012.

Considering that the Commission is still in the process of evaluating the instant application, the provisional authority granted in the Order dated January 31, 2011 is hereby **EXTENDED** until revoked or made permanent by the Commission.
