

BID BULLETIN NO. 02, Series of 2011

WHEREAS, the ERC Bids and Awards Committee (BAC) posted the Invitation to Apply for Eligibility and to Bid for the Procurement of CT/PT Tester with accessories (Lot No. 2011-02) in the Philippine Government Electronic Procurement System (PhilGEPS), Daily Tribune newspaper, ERC website and bulletin boards within the ERC Main office building on 03 June 2011;

WHEREAS, the Bids and Awards Committee held a Pre-Bid Conference on 10 June 2011;

WHEREAS, during the said pre-bid conference, the present bidders requested clarification from the Bids and Awards Committee (BAC) on the following provisions of the Bid Documents, to wit:

WHEREAS, the BAC clarified and restated the abovementioned provision of the Bid Documents, as follow:

WHEREAS, the BAC instructed the bidders to submit one (1) original (certified true copies) and one(1) copy of the Eligibility and Technical Components and Financial Components of its bid, as stated in Section III. Bid Data Sheet, 20.3;

WHEREAS, the BAC resolved that all columns in the form for goods offered from abroad should be filled-up, including:

(a) Column 8 – Unit price Delivered Duty Paid (DDP) (e.g. taxes, custom duties paid); and

(b) Column 9 – Total Price delivered DDP;



NOW THEREFORE, for and in consideration of the foregoing, the BAC hereby resolves as it hereby resolved to modify and amend the aforesaid provision of the Bid Documents to read as follow:

(a) "Section III – Bid Data Sheet
ITB clause 12.1(b)(ii)

- 1) One (1) original (certified true copies) and one(1) copy of the Eligibility and Technical Components and Financial Components of its bid, as stated in Section III. Bid Data Sheet, 20.3; and
- 2) Completely filled-up form for goods offered from abroad, including column 8 (Unit Price Delivered Duty Paid [DDP]) and column 9 (total price delivered DDP).
