

**ERC BAC RESOLUTION NO. 24, Series of 2011**

WHEREAS, the ERC published the Invitation to Bid on October 28, 2011 for the **Supply and Delivery of Meter Stickers** at the Daily Tribune newspaper and posted continuously at the ERC website, the Philippine Government Electronic Procurement System (PhilGEPS) and bulletin boards in the premises of the ERC;

WHEREAS, clarifications were made by parties concerned during the Pre-bidding conference on November 9, 2011 at eleven o' clock in the morning (11:00 A. M.);

WHEREAS, during the scheduled Opening of Bids at eleven o'clock in the morning (11:00 A.M.) on November 22, 2011, the following bidders submitted their bids:

WHEREAS, DTM submitted the Lowest Calculated Bid of **One Million Forty Thousand Pesos (PhP1,040,000.00) VAT inclusive**;

WHEREAS, after the post qualification conducted by the BAC Technical Working Group (TWG), it was found out that DTM complied with all the required Legal, Technical, and Financial Requirements declaring the bidder eligible;

WHEREAS, the BAC-TWG recommended in its Memorandum dated November 23, 2011, that DTM be considered for award for offering the **Lowest Calculated Responsive Bid (LCRB)** with its proposal of **One Million Forty Thousand Pesos (PhP1,040,000.00) VAT inclusive** which is lower than the Approved Budget for the Contract (ABC) of **Two Million Eight Hundred Eighty Thousand Pesos (PhP2,880,000.00) VAT inclusive** for the Supply and Delivery of Meter Stickers;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**, to **recommend to the Chairperson of the ERC to declare DTM Print and Labels Specialist, Inc. as the Lowest Calculated Responsive Bidder.**
