Interested parties must submit their duly accomplished Bids and Eligibility requirements by depositing it in the **BID BOX** located at the 12th Floor, Pacific Center Bldg., San Miguel Ave., Ortigas Center Pasig City on **September 22, 2010, 1:30 PM**. The official time shall be based on the wall clock located at the 12th Floor. **Late bids will not be accepted.**
