

ORDER

On 28 March 2014, the Camarines Sur II Electric Cooperative, Inc. (CASURECO II) filed an Application for the approval of over or under recoveries based on the formula of various adjustments and true-up mechanisms and corresponding confirmation process for the period January 2011 to December 2013, pursuant to *ERC Resolution No. 16, Series of 2009*, as amended by *Resolution No. 21, Series of 2010*, and *ERC Resolution No. 23, Series of 2010*.

On 12 January 2015, the Commission issued an *Order* setting the instant Application for initial hearing on 09 February 2015.

On 05 February 2015, CASURECO II filed a *Motion for Cancellation of Initial Hearing Scheduled on 09 February 2015* due

to insufficient time to comply with the jurisdictional requirements of the Commission.

Finding the said *Motion* to be meritorious, on 09 February 2015, the Commission issued an *Order* granting the same and cancelling the hearing set on 09 February 2015 until further notice.

NOW, THEREFORE, the said hearing is hereby reset on **11 July 2016 (Monday) at two o'clock in the afternoon (02:00 P.M.) at the ERC Hearing Room, 15th Floor, Pacific Center Building, San Miguel Avenue, Pasig City**, for determination of compliance with the jurisdictional requirements, Expository Presentation, Pre-trial Conference, and presentation of evidence.


CASURECO II is hereby directed to cause the publication of the attached Notice of Public Hearing, at its own expense, once (1x) in a newspaper of general circulation in the Philippines, at least ten (10) days before the date of the scheduled initial hearing. It is also directed to inform the consumers within its franchise area, by any other means available and appropriate, of the filing of the instant Application, its reasons therefor, and of the scheduled hearing thereon.

Let copies of the Application, this Order and the attached Notice of Public Hearing be furnished the Office of the Solicitor General (OSG), the Commission on Audit (COA), and the Committees on Energy of both Houses of Congress. They are hereby requested, if they so desire, to send their duly authorized representatives at the scheduled hearing.

Likewise, let copies of this Order and the attached Notice of Public Hearing be furnished the Offices of the Provincial Governor, City and Municipal Mayors, and the Local Government Unit (LGU) Legislative Bodies within CASURECO II's franchise area for the appropriate posting thereof on their respective bulletin boards.

CASURECO II is hereby directed to furnish all those making requests therefor with copies of the Application and its attachments, subject to reimbursement of reasonable photocopying costs.

On the date of the initial hearing and Pre-trial Conference, CASURECO II must submit to the Commission its written Compliance with the jurisdictional requirements attaching therewith, methodically arranged and duly marked, the evidence of the actual posting and publication of the Notice of Public Hearing consisting of



certifications issued to that effect, signed by the aforementioned Governor, Mayors, and LGU Legislative Bodies, or their duly authorized representatives, bearing the seals of their offices, and the affidavit of the Editor or Business Manager of the newspaper where the said Notice of Public Hearing was published, together with the complete issue of the said newspaper, and such other proofs of compliance with the requirements of the Commission.

CASURECO II and all interested parties are directed to submit, at least five (5) days before the date of initial hearing and Pre-trial Conference, their respective Pre-trial Briefs containing, among others:

- a) A summary of admitted facts and proposed stipulation of facts;
- b) The issues to be tried or resolved;
- c) The documents or exhibits to be presented, stating the purposes and proposed markings therefore; and
- d) The number and names of the witnesses, with their written testimonies in an individual affidavit form, to be attached to the Pre-trial Brief.

Failure of CASURECO II to submit the required Pre-trial Brief and Judicial Affidavits of its witnesses within the prescribed period shall be a ground for cancellation of the scheduled hearing, and the resetting of which shall be six (6) months from said date of cancellation.

As part of the Pre-trial Conference, CASURECO II must also be prepared to make an Expository Presentation of its Application, aided by whatever communication medium that it may deem appropriate for the purpose, in order to put in plain words and explain, for the benefit of the consumers and other concerned parties, what the Application is all about and the reasons and justifications being cited in support thereof.



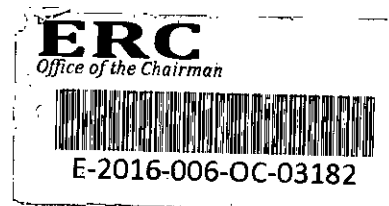
