ORDER

On 27 February 2015, First Bukidnon Electric Cooperative, Inc. (FIBECO) and Maramag Mini Hydro Power Corporation (MMHPC) filed an Application for the approval of their Power Supply Agreement (PSA), with prayer for the issuance of provisional authority.

Relative thereto, on 11 May 2015, the Commission issued an Order provisionally approving the Application.

Section 4 (e), Rule 3 of the Implementing Rules and Regulations (IRR) of Republic Act No. 9136, or the Electric Power Industry Reform Act of 2001 (hereinafter, "EPIRA") provides the period within which the Commission should resolve the Application, upon grant of provisional authority, thus:

SECTION 4. Responsibilities of the ERC. -

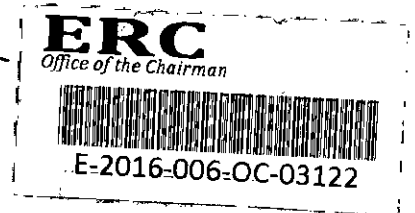
Thereafter, the ERC xxx shall decide the matter on the merits not later than twelve (12) months from the issuance of the aforementioned provisional order. [emphasis supplied]

In view of the forthcoming expiration of the aforementioned twelve (12) months period, and considering that the Commission is still in the process of evaluating this Application, the provisional authority granted in the Order dated 11 May 2015 is hereby **EXTENDED** until revoked or made permanent by the Commission.




